Dear Subnananda Prabhu

Please accept my humble obeisances. All glories to  
Srila Prabhupada.

Thank you for taking the time to write. I apologize for  
not replying sooner but I've been very busy and my plans  
underwent a somewhat dramatic change when Kailasa Chandra  
has decided to contribute the documents he possessed. I  
will respond to your points in order.

First I apologize if I offended you for your book on  
Guru. What your intentions were for compiling it, only  
you and Krsna know. One thing we all know however is that  
it did not prevent these men from appointing themselves  
"guru" and then falsely taking worship as though they  
were uttama adhikaris, thus practically destroying the  
mission and the enthusiasm of all our Godbrothers. In  
this way the book was a complete failure. Of course at  
the time you may have been just as naive as the rest of  
us as to the degree of corruption going on amongst these  
"top men" so, again, I apologize if I offended you. You  
say that you took only references from the books but  
there are many references in the books as to how bogus it  
is to appoint a guru. You didn't mention those. The book  
was financed by Ramesvara so I can easily understand your  
position.

Your suggestion that "if I could go about my work with  
a "cool head" is very much appreciated. That is exactly  
what I'm doing. Otherwise I would have gone to NV with a  
shotgun and blown Kirtanananda's head right off his trunk  
long ago. There would have been no reaction for doing so.  
I've already proven that Kirtanananda is a demon and the  
silence from his side confirms it. This expose I'm  
compiling is actually the "cool" course of action for me  
and is really the only weapon I have to get my sons away  
from the Raksasa. The GBC has, as I predicted, been  
unable to get any sympathy from KS (not that they really  
tried very hard). he laughs at them just like he laughed  
at me. Lord Ramacandra also got laughed at by Ravana when  
Rama demanded His wife back. This is the standard symptom  
of demons since time immemorial just before they are  
destroyed. They feel so powerful that they can even steal

other mens wives. History has shown this. The Kurus also were not utterly doomed until they stole Draupadi. So even though this is Kali yuga and none of us are on the level of any of the above personalities, still, there is a direct relationship.

Your statement that "no movement has ever been reformed by threats etc..." I cannot figure out how you came to this conclusion. My position is simply this. Kirtanananda has clearly shown himself to be nothing but a demon. I have proven this. No one disagrees who has read my expose's on him. I've given the GBC ample opportunity to rectify KS and themselves. They refused. In Vedic culture this would mean a violent war would take place. Wars indeed have many times "reformed" a movement. Due to these present circumstances however, physical war is out of the question. So the only other weapon is the media. I'm only doing what I have to do. These are my options. (1) Go to NV and kidnap my sons. Then I have to live in hiding for who knows how long. Even though the sons belong to the father in our religion, they (KS) are taking shelter of the karmi laws which give children to mothers. (2) Go to NV and kill Kirtanananda. Then I have to live as a fugative since the karmis don't consider wife-stealing, and child kidnapping crimes punishable by death. (He has destroyed numerous lives besides just my wife's.) (3) Work like an ass to make enough money to hire a lawyer who may just be able to get me partial custody. I won't allow my sons to remain in KS's demonic presence for even a moment so that is out of the question. (4) Present my case to the GBC and leave it up to them. I've done that and they have failed to influence KS. They are, for the most part, guilty of the same crimes so I didn't really expect them to be much help. (5) Make a major media exposure of all ISKCON and file a large law suit against the entire organization. Only in this way will I be able to attract a good lawyer. This book I'm producing now is all the evidence I need to get any jury in the country to get my sons back to me, and naturally it will start a chain reaction. If it weren't for my sons being in KS's grip I would most likely just distribute this book within the society, but since I need a lawyer to get legal custody, I have to go public. Sorry. I have no choice. The GBC has failed. If you want to donate \$20,000, I may be able to get custody without big public exposure but I don't think you or anybody else cares enough about my sons to spend that kind of money. So your statement to "yell and scream bloody murder" is exactly what I'm doing. Thank you.

Your next paragraph is interesting. Not only do I think Prabhupada would want me to do what I'm doing, but he

himself set that example in the way he condemned his bogus Godbrothers. He called Bon a black snake. He publically exposed them all. Bon never attacked his guru as KS did in 1967. Bon was never a faggot. Bon never stole a Godbrothers wife and turned her into a por. Bon never dealt in drugs. Bon was never in a mental institution. Bon never killed cows. All in all I think Prabhupada is very pleased that these demons are finally being exposed for what they are. But, if indeec, as you say, Prabhupada does not want this book published and mass distributed, then it simply will not happen. I'm not attached to the result. Man proposes, God disposes. Krsna may want me to remain single. When I get my sons back I will naturally have to remarry. I am responsible for my sons and so I am doing my duty, that's all. If Krsna wants it done, then I am doing it. Krsna can easily stop me at any moment, but instead, He appears to be providing me with all the facility and encouragement I could possibly want. So ultimately we will see what Prabhupada wants.

This concept that "ISKCON" is Prabhupada is foolishness. Do you really think Prabhupada is behind this corrupt GBC? If you do, then I hate to have to say this, but that means you are either waiting in line to be appointed yourself, in which case you would not be able to see anything clearly, or you may still be a little naive about these men, in which case this book will be a real eye opener for you also. The GBC severed their link with Prabhupada long ago when they appointed themselves "gurus" (note revised May "appointment" transcript enclosed). Even without so much hard evidence, the character of these men clearly exposes them. So just some friendly advice Praonu. I don't really know you at all. We only met once in the Dallas restaurant last year just after I left NV. and we didn't talk about anything much. So please don't take this personal. I give this advice to everyone. "ISKCON" is absolutely finished. The sooner you join Prabhupada's side fully in this fight, the more you will be able to take part in the victory. Just like Krsna didn't need Arjuna to end the Kurus, similarly we will publish this book and mass distribute it no matter how many devotees come forward to help. The sooner you sever your link with that corrupt organization, the less implicated you will be when they are smashed. If you wait until they are fully smashed to see the light, that won't mean much or reflect very highly on you. Everyone will wake up then, no matter what their motivation or realization may be.

If you decide you would like to help in a practical way to purify ISKCON then I will certainly be able to engage

you. Right now we have a board of approx. 12 brahmins, all old and sincere devotees, who are going to review the final copy before printing. The main idea is to make it as strong and pure as possible with the sole intent of revealing to the world that Prabhupada never had anything to do with the corruption that Karmis experience and read about "ISKCON." To do this is sensitive. The media would just assume see Prabhupada smashed along with "ISKCON." But they will not want to reject the book either because it has a lot of very juicy facts in it. So its a juggling act for them. Our aim is to make it as easy as possible for them to accept the book and advertize it, without compromising Prabhupada's greatness. If you want to be on the board of reviewers, you are welcome, but I would need something from you to guarantee that you will not allow a copy to be made and given to the GBC. They will try to put a restraining order on it. You will have to have a lawyer draw up an agreement that you will review the book without allowing the GBC or any "ISKCON" man to get hold of it. Only then will I be able to send you an advance copy. I'll call you to discuss details if you are interested. I'm sure your contribution to this book would be invaluable. The devotees will have a week to read and think about all the chapters, and mail all their ideas to me. I will then organize them all and mail them back for final voting on what's to be included and what's to be left out. If you feel something should be left out for any reason, that argument should be made clearly and it will be mailed to all the voters. It may be necessary for a second review and vote but I doubt it. The names of the devotees will be kept confidential unless otherwise stated. I am making this offer to you because of your knowledge in dealing with the public. No other "ISKCON" PR men are involved as yet.

Again I thank you for writing. We are going with a professional printing job since the book is close to 300 pgs. Hopefully it will be complete in a month. The name will be voted on. I was thinking something like; ISKCON'S NEW GURUS--"THE MOST DANGEROUS ELEMENTS IN HUMAN SOCIETY" (sub)THE CONSPIRACY THEY NEVER WANTED REVEALED. Your suggestions will be welcome. I look forward to hearing from you again.
