Dear Triyogi das

Please accept my humble obeisances. All glories to Srila Prabhupada.

I don't believe we have met but I wanted to let you know that there are many of us out here who are grateful for what you've done. I don't know what your motive was but I know that KS is a very demoniac man and deserved much more than what he got. The Yamadhuttas will carry on where you left off. I'm not a physical type person myself, so I have been attacking him by public exposure. By Krana's mercy I've had rather good success in that endeavor. In fact, the very morning you hit him KS called up Atreya Rsi here in California and was trying to make arrangements to send my sons back to me in hopes that would stop me from exposing him further. He must have sensed something heavy was about to happen to him but misinterpreted it as my launching a media campaign against him. I was actually a little sorry to hear this had happened for I was expecting to see my boys within days. Now the negotiations are on hold for who knows how long. If he dies there's no telling what's going to happen. I suspect NV will disintegrate within months. It's a personality cult and when the personality dies, it's all over.

Ultimately it was Krana's arrangement that this has happened. Violence was inevitable since these "gurus" had done so much damage to Prabhupada's movement and disciples. The only amazing thing is that it took this long to start happening. KS had Jadurani beaten five years ago. Personally I predict several more "gurus" will be attacked in the next few months. Enclosed is a recent circular that I'm sending to the ksatriya devotees who follow Prabhupada. It explains some of the intricasies of violence and its application according to our scriptures. I hope it will help you formulate your defence. You may be feeling some hatred coming from the handful of zombies who think KS is a human being but rest assured, he had many more enemies than friends. As Prabhupada said, "A saintly person takes pleasure in seeing snakes and scorpions killed." In that letter he let it be known that this also applies to men who are like snakes and scorpions. Prabhupada directly called KS in letters, "a creature," a "crazy man," a "Mayavadi," a "jackel,"

to mention a few. Why K5 had a position in ISKCON is fully explained in chapter two of my book, The Guru Business. Prabhupada was expert in keeping even the worst of demons engaged and out of trouble. If Prabhupada hadn't encouraged KS to develope NV, then KS would have continued attacking Prabhupada. NV was just throwing KS a bone to keep him out of trouble. That's all it boils down to.

It's a shame this country's legal system allows such men to enact their demoniac plans using innocent citizens as pawns. For this reason it is sometimes necessary to take the law into our own hands. This government just plain can't or won't take the responsibility. They are too busy passing laws allowing abortion, pornography, prostitution, intoxication, etc., or they're too busy spending the payoff money they get from the men thriving off those "businesses." So they won't help us get justice. They don't even know it's wrong to pose as a holy man because they don't believe in God, or they think God has nothing to do with them, which is the same thing. Actually it's this government that's responsible for what happened to KS and not you. You only did what the Government should have done long ago. Judge Warmuth there in Moundsville is a perfect example of one such corrupt government representative. On KS's behalf, he gave my wife a divorce and custody of my sons without even thinking it necessary to notify me of the hearing. That makes him responsible for my wife's now being one of KS's common hors. By Vedic law that "judge" could be punished for this crime. So there is just no way to deal with this country's legal system. They are worse than the violent criminals because they pass laws which allow and even encourage degredation in society. I'm hoping this incident will spark a major controversy over these issues.

For instance, for the past year I've been interviewing many of KS's victims. I have numerous testimones of how he directly breaks up marriages, forces young 13 year old girls to sleep with 26 year old men of degraded character, even ignores it when these young girls are raped as in the case with Ambarisha who raped two girls around 12-13 years old. He tells men to beat their wives; forces women out on the streets against their will and puts their infant babies in a nursery with 20 other infants to be looked after by one 10 year old girl, etc. etc. The list goes on indefinitely. Do you think this country's courts are interested in these

testimonies? Hell no! To press charges against this kind of thing requires too much money, and KS is the only one who's got money. And if someone presses charges they have to live in fear for their lives. So he is free to go on exploiting women any way he likes. It's incredible what he's gotten away with over the past 20 years. What you have done is really the only way to stop a man like KS in this country and so your action is praiseworthy.

Anyway, I'm sure you couldn't help yourself once you realized who KS really was. I suspect right at that moment Krishna inspired you to do what you did. You could not have done that without the sanction of the Lord. KS is too big a demon. He's one of the kingpins in ISKCON so rest assured, Krsna had His hand in your action. Just like Krsna inspired Arjuna to kill millions of demons on the battlefield of Kurukshetra, including his own relatives, so it was not at all surprising to see Krsna use you to kill this demon. You may not be Arjuna, and your motive may not have been as pure as Arjuna's, but then KS is not Duryodhana either. Duryodhana was a gentleman compared to KS. Krsna can use whomever He likes to do whatever He likes. Let the courts try to prosecute Krana. I'm just curious as to why He gave you the honor of executing KS instead of one of the more deserving victims. Anyway it's done and that's the important thing.

I'm planning on exposing all these ISKCON "gurus" to the media very soon. I would like to know more of your personal situation before doing so. I may be able to help you in regards to public opinion since I have gathered enough evidence right now to prove that KS deserved exactly what he got. So please get back to me as soon as possible. If your lawyer arranges it, I may be allowed to talk to you over the phone. I'll try calling you after this letter reaches you. I wouldn't be depressed if I were you. If there is any reaction at all coming your way it won't be much. The good that will result from your action far overshadows any ill motive, if any, that may have been there on your part. I'll be looking forward to talking with you.
